5. Aims and objectives of your organisation; What does your organisation do and how does it benefit the residents of Weymouth?

Brazilian Jiu Jitsu is a predominantly ground-based martial art, using the principals of leverage, angles, pressure, and timing, to achieve a submission of one's opponent without causing injury. Recently, the UK's governing body (UKBJJA) have created a GCSE course to encourage and grow Jiu Jitsu among young people and make it part of the school curriculum. Other countries have made Jiu Jitsu their national sport and part of the school curriculum from a young age.

Jiu Jitsu has huge physical and mental heath benefits for its practitioners and teaches virtues such as discipline, respect and perseverance. Socially, training together creates strong friendships and a family environment.

We are a newly formed non-profit, committee lead Brazilian Jiu Jitsu club in Weymouth. We aim to provide a clean and safe training environment for our members and the wider community and deliver high quality Brazilian Jiu Jitsu classes. Most other clubs are profit based and are often the instructors main source of income, it is very rare for clubs to be non-profit, which allows us to re-invest membership fees into supporting our members and the wider community.

We are currently renting space in a fitness studio teaching 4-5 classes per week. Long term we would like to move to a permanent home and expand our offering, adding children's classes, teaching in schools and offering services such as a creche for our members, allowing couples and families to train together.

All of our instructors have enhanced DBS checks, NSPCC safeguarding training and are in the process of becoming first aid qualified. We have elected a club welfare officer to ensure we fulfil our duty of care towards our members and are an inclusive club, open to people of all ages, backgrounds and orientations.

Competition is at the heart of Brazilian Jiu Jitsu and we will be looking to subsidise our members competition fees to support the team and enable more of our students to compete.

13. Briefly describe the project or purchase you would like the funding for:

The largest portion of the funding would go towards mats. This is essential for us to be able to train. Currently we are using borrowed mats from our members, and would like to purchase high quality rollout mats to give us maximum flexibility.

Many of our members have expressed interest in competitions and we would like to provide them with a team uniform, as well as subsidising competition entry fees and travel from club profits.

We have also included 2 playpens. Most of our members have young children and it is hard to find time to train. By having a safe space close to the mat for children, members will be able to bring them along and give their partner a break for the evening, or enable couples to train together.

We need a countdown clock to use as a round timer, this is essential for many of the warm up drills as well as competition training and regular sparring.

Additionally, we require cleaning products.
