- 5. Aims and objectives of your organisation; What does your organisation do and how does it benefit the residents of Weymouth? Doppelganger Productions is a theatre company based in Dorset which produces innovative new writing. We are especially interested in new work from Dorset-based playwrights and in finding, nurturing and supporting emerging writers. While Doppelganger Productions is based in Bournemouth, this project will be taking place within the communities of Weymouth and Portland. Our Artistic Director is BAFTA Award winning writer, John Foster.

- 13. Briefly describe the project or purchase you would like the funding for: Our Director Charmaine K (SISATA) is leading this ambitious project that is driven by and cocreated with the community. A 50+ member company created from a mix of local professional artists and residents to encourage intergenerational understanding and collaboration to shape a bright future. Empowering and expanding community participants with resilience, skills, confidence and aiding wellbeing through creative community activity. Inspiring SISATA's national playpark workshops, four-hander touring production and culminating in an original community driven, site-responsive, interactive and immersive Portland Peter Pan event at the b-side Festival in September. The four-hander production will tour to several venues across Dorset including Sandsfoot Castle Gardens, Abbotsbury Tithe Barn, Portland Castle and Dorchester Arts in August and September. We are applying for funds to deliver this community activity and to support and subsidise people of Weymouth who may have financial barriers to join in the community activity.

18. How will the funding benefit the community or residents of Weymouth? We will facilitate intergenerational cooperative participation in creative arts to bridge understanding between the demographics, whilst developing participants skills and confidence and boosting wellbeing through creative community activity. To do this, we will connect community members from across Dorset with professional artists to enable skill sharing through the development of a cocreated community-driven event. Inspired by the story of Peter Pan and drawing on the themes of fresh, fearless, innovative youth v's the wisdom of age and experience we will bring different generations of Weymouth and Portland residents together to co-create a site-responsive immersive theatrical event set on Portland. We will use the concept of Neverland as a utopian ideal to encourage generations to work together to actualise a better future. As climate change is one of the biggest challenges we all face, there will be a consideration of what Utopia means. Weymouth and Portland is one of the most deprived areas in the county and antisocial behaviour by certain groups of teenagers is a real problem. Through our work in 2023, we were able to engage with The Drop In youth service who told us how frustrated they are that many of the young people they work with are "tarred with the same brush" as those who are instigating the

antisocial behaviour and that this seems to stem from a lack of understanding between the generations. Weymouth and Portland residents of different generations will work together with the shared goal of creating a festival event. Additionally, we would like to empower the community to bring their various skills together so that they have the knowledge and experience to instigate their own projects in the future. This work we do in Weymouth and Portland will inspire the 4-hander SISATA tour, sharing the close-knit community exploration with a national audience. We will hold a series of community workshops and work with local practitioners to create a shared vision of our Neverland. Weymouth and Portland residents will be given the choice to work with local practitioners of different disciplines of their choice (dance/movement, parkour, puppeteering, music, etc) to devise this immersive, interactive, theatrical experience in response to an outdoor location on Portland, Church Ope Cove and the surrounding area of St Andrews Church, known locally as the Pirates Graveyard. We will share skills and experiences and encourage participants to understand each other's aims and objectives in order to reach our shared goal of creating this event. We will use techniques such as Forum Theatre to resolve any conflicting ideals. The different demographic groups will be engaged through the various organisations: AUB and Bournemouth University students; Grace+Growl (a community dance company of older dancers); The Drop In Youth Service; b-side; Portland Players and The Offshoot Collective community theatre groups; Island Voices and Weymouth's Harmonics Community Choir. If awarded this grant, not only will this pay for the local creative practitioners to run the workshops in the community, the money will make this project more accessible to those that are experiencing financial hardship by offering to reimburse travel expenses, provide food, and purchase materials for the workshops.

- 20. How do you know that the groups you work with, or the local community, want this project to take place? Please detail any consultation undertaken: **Our work with The** Drop In on last year's Portland Project Tempest coupled with the rise in antisocial behaviour has demonstrated to us the drastic need for more engagement with young people in the local area and for the generations to come together with a shared goal. What we discovered through our community work on The Tempest illuminated the impact of climate change on coastal communities. However, there was no solution to the problem and this project will focus on enabling people to brainstorm ideas in a creative way and work together to shape a positive future. We would like to build on our existing knowledge and experience of community theatre by using theatrical techniques such as forum theatre (something we have worked with before but in a limited capacity) within a community setting to explore notions of what it means to live in harmony and create a better future. On the SISATA tour we want to use the playpark workshops to engage with people who might not have the option to experience live theatre due to the cost of living crisis. Within this format, we will also explore some of the issues we have uncovered in the community workshops. Unlike the 2023 Project Tempest, there will be more focus on young people and we will bring in other practitioners to work in different disciplines such as

improvisation and puppetry. There will also be a focus on skill sharing and empowering the community to launch into instigating the creation of their own work going forward.

- 21. How will this funding lead to greater self-sufficiency and lessen the need for future applications? We want to empower the community with the skills needed to create their own work and help them to fundraise themselves for future community activities.
- 22. Weymouth Town Council declared a Climate and Ecological Emergency in 2019 and is keen to ensure that environmental impact reduction and opportunities for environmental enhancement are mainstreamed through its work.

How will this project help improve the environment and what mitigation measures will be put in place to limit environmental impacts such as use of single use plastics, waste generation, sustainable travel, reducing energy usage? The project focuses on the impact of climate change on coastal communities and aims to bring the community together to seek solutions. We are also following and applying our environmental policy throughout all the activity in the project. Working alongside the Arts University Bournemouth students, all the costumes are being created using recycled and found materials. Being eco and environmentally aware will play a huge part in the creation of the event.

- 23. How is your organisation normally funded? Not applicable to new organisations: **Arts Council England and show ticket sales.**
- 24. What are your current/planned subs/fees/charges? The ticketed national touring Peter Pan show is self-sufficient and not for profit. Linking the two activities helps to promote them both locally and nationally. We make the community workshop activities free for the public for accessibility. There are free playpark workshops accompanying the touring production for children/families to still be engaged with the work without having to see the show.

The community workshop activities are free for the public for accessibility. It is not expected, but should we make a profit from the project, it would go towards our next Weymouth community project.

26. Have you applied for any other funds/grants towards the cost of this project or purchase? Please include details below: Our Assistant Producer secured a grant towards her research and prep for the project. The Arts University Bournemouth are on board as partners, their students are already creating the costumes as

- part of their course and Portland Marina are on board to host the workshops, both through in kind support. We have applied for the maximum grant available from Portland Town Council to cover the access needs of Portland participants.
- 27. What fundraising activities took place in the last 12 months and what fund-raising activities are planned for the next 12 months, if any? We were successful with our 2023 Arts Council funding application which gave us 30k to run the Tempest Project in the local area. We were unsuccessful in our last Arts Council funding application to fund this project. They said it had no weakness, but they have limited funds. This grant will ensure the planned activities take place. We plan to apply to ACE again for future projects.
