

## TEMPORARY TRAFFIC MANAGEMENT NOTICE OF VARIOUS ROADS, WEYMOUTH FOR WEYMOUTH REMEMBRANCE PARADE

DORSET COUNCIL has issued a Notice under Section 16A of the Road Traffic Regulation Act 1984 to prohibit the use of various roads as set out below by cyclists, horse riders and all mechanically propelled vehicles, except those taking part in the event and emergency vehicles, to facilitate this public event on the highway.

The effect of this notice is as follows;

On Saturday 9 November 2024 and Sunday 10 November 2024;

[1] To impose temporary closure of The Esplanade between William Street and King Street on Sunday 10 November 2024 between 1000hrs and 1200hrs

[2] To impose temporary closure of The Esplanade between King Street and King Statue on Sunday 10 November 2024 between 1200hrs and 1230hrs

[3] To impose temporary parking suspension and clearway on both sides of The Esplanade between its junctions with King Street and Lennox Street on Saturday 9 November 2024 between 2100hrs until approximately 1200hrs on Sunday 10 November 2024

[4] To impose temporary parking suspension along Astrid Way on Saturday 9 November 2024 between 2100hrs until approximately 1200hrs on Sunday 10 November 2024

[5] To impose temporary parking suspension on Brunswick Terrace in front of the Pier Bandstand as indicated by signs on site on Saturday 9 November 2024 between 2100hrs until approximately 1200hrs on Sunday 10 November 2024

[6] To impose temporary clearway in the area in front of Enzo's Restaurant as indicated by signs on site on Saturday 9 November 2024 between 2100hrs until approximately 1200hrs on Sunday 10 November 2024

Any vehicle waiting in contravention of the restrictions imposed by this Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986. Any vehicles within the restricted parking areas will be removed and placed in Swannery Car Park, the owner will need to contact the towing contractors Bartletts Recovery on 07054953181.
