TEMPORARY TRAFFIC MANAGEMENT ORDER OF VARIOUS ROADS, WEYMOUTH FOR ARMED FORCES DAY PARADE 2025

DORSET COUNCIL has issued a Notice under Section 16A of the Road Traffic Regulation Act 1984 to prohibit the use of the following roads by cyclists, horse riders and all mechanically propelled vehicles, except those taking part in the event and emergency vehicles.

On Sunday 22 June 2025 between 10:00 and 13:00 there will be temporary road closures imposed on the following roads or as indicted by signs on site;

- Greenhill (from its junction with Dorchester Road to The Esplanade)
- Brunswick Terrace/Waterloo Place
- William Street (from Greenhill to Victoria Street)
- Lennox Street (from The Esplanade to Victoria Street)
- Astrid Way
- The Esplanade (for its entire length)
- Pilgrims Way
- South Parade
- Belle Vue

Roads will reopen as soon as practicable after the Parade, which will march from the Cenotaph near Brunswick Terrace to the Pavilion Theatre. Alternative routes for traffic entering and leaving the town centre will be fully signed for the duration of the Parade.

Parking suspensions will be imposed at the following locations from 1500, 21 June 2025 until 22 June 2025 at approximately 13.00 or until the above roads are open;


- Both sides of the Esplanade from East Street to Greenhill (from its junction with Dorchester Road to the Esplanade) including Waterloo Place and Brunswick Terrace
- The seaward side of Alexandra Gardens
- Astrid Way

For the duration of the event, Permit Holders for Zones C, F & H will be permitted to park in the Pavilion Car Park and the Swannery Car Park from 1500, Saturday 21 June 2024 until 08.00, Monday 23 June 2025. Any vehicle waiting in contravention of any restriction imposed by this order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986. If a vehicle has been towed the owner will need to contact our towing contractors Bartlett on 01305 783675/07967606150.
