3. Aims and objectives of your organisation; What does your organisation do and how does it benefit the residents of Weymouth?

Artwey CIC is a volunteer-led organisation, and our mission is to champion visual arts in our community and to empower local artists to engage, connect, and inspire. Our aims are to:

- Promote art and local artists
- Make art accessible to all and, through it, to enhance well-being, social cohesion, and local pride across Weymouth and Portland.
- Bring art to residents and visitors by fostering creativity, inclusion, and cultural participation.

Our work spans exhibitions, workshops, and outreach programmes. Recent initiatives include creative workshops for asylum seekers on the Bibby Stockholm, an Art for Peace event, community art sessions in Radipole Gardens and a pop-up community art shop. By raising funds for causes like the Lantern Trust and the Women's Refuge, we reinforce art's potential as a tool for social impact. Our events align with Weymouth Town Council's cultural strategy, contributing to a vibrant, inclusive economy and making the arts a vital force for community transformation.

# \*\*Exceptional Circumstances

We are applying for £5,000 due to the scope and scale of our project.

We have tried other sources to get funding for this project. For example, several of our member artists previously applied for individual funding through the Town of Culture Reveal Grant but all were unsuccessful. Upon reflection, we consolidated our ideas, ensuring a collaborative approach under the respected umbrella of Artwey CIC, allowing us to maximize impact and deliver a cohesive, high-quality initiative.

In addition, Artwey CIC had a commitment to run the Open for Art art trail in 2025 and we were only able to achieve £1700 of funding. Despite this, we met that commitment but doing so has severely depleted our assets. Therefore, other than the £1500 which we have already set aside for the Crossing Different Paths project, Artwey can allocate no more this financial year.

We believe our project meets the criteria for exceptional funding, as it directly contributes to and supports the 2025 Dorset Town of Culture events. Our work strengthens Weymouth and Portland's reputation as towns that prioritise and actively promote the benefits of art, mental well-being, and community engagement. Through our initiative, we aim to not only enhance the cultural landscape but also create lasting opportunities for artistic participation, social cohesion, and economic enrichment. The additional funding will enable us to deliver an event of significant scale and meaningful impact, ensuring accessibility and inclusivity for all members of the community.

4. Briefly describe the project or purchase you would like the funding for. Please include how will the funding benefit the community or residents of Weymouth? How do you know that the groups you work with, or the local community, want this project to take place? How will this funding lead to greater self-sufficiency and lessen the need for future applications?

Crossing Different Paths is a creative celebration of Weymouth and Portland's rich cultural diversity as part of Dorset Towns of Culture 2025. Led by six Artwey CIC artists in collaboration with local organisations supporting marginalised communities, this initiative features five unique arts events in accessible public spaces. Through visual art, participatory workshops, and community-led storytelling, we'll spark dialogue, foster mental well-being, and cultivate a shared sense of belonging. By bridging cultures through creativity, the project promotes inclusive engagement and affirms the vital role of the arts in strengthening our community's identity, mental well-being and cohesion. The following are brief descriptions of each of the five events:

# **Event 1 – "Hope and Deprivation".** Consists of three elements:

- 1. Workshops held with clients of the Lantern Trust exploring healing, hope, and integration through art
- 2. As an immigrant to Weymouth, Mexican Artist Silvia will focus on integration into the community through elements of Mexican Art, traditions, culture, flora and fauna. Local artists will be asked to contributed Mexican inspired artworks.
- 3. A two-week August exhibition at Holy Trinity Church in August 2025 featuring all the above and including sculpture, a folk-dance performance and a children's art competition. Donations will be encouraged to go to the Lantern Trust, reinforcing the event's commitment to social impact and community well-being.

# Event 2 – "Frame the View" Weymouth's Big Draw August 2025

Held at Greenhill Gardens and inspired by the National Gallery's outdoor drawing event "Sketch on the Square" and Seafest, this public drawing session led by Artwey artists will invite residents and members of the public to sketch framed views. Materials will be provided free of charge and a pop-up exhibition will showcase the work. Donations will be encouraged to support costs, and surplus funds will be shared between Greenhill Gardens and Artwey.

# Event 3 – "Helping Hands" August 2025. Consists of four elements:

- 1 and 2. Two clay sculpture workshops targeting local youth groups (but all residents can have a go).
- 3. A live interdisciplinary performance creating new sculptures from elements of dance, yoga, drama and music
- 4. A final exhibition with performances at Portland Community Venue and Chesil Beach.

# **Event 4 – "Rooted"** (Working Title) **Over several months.**

Artist Catherine Mason will co-create a growing patchwork scarf through a series of workshops with refugees and immigrants in Weymouth and Portland, each piece sharing a personal story. The project highlights the area's frontline role in housing displaced people from Ukraine, Afghanistan, and beyond.

# **Event 5 - Heart Felt (Cherished Keepsakes) October 2025**

Marginalised groups, vulnerable people and members of the public will be invited to share stories about objects which are so meaningful in their lives that they have become cherished keepsakes which they can't give or throw away. With their

permission, the stories will be recorded (either video or audio) with the intention to explore memory and emotional connection. The objects themselves will be collected and placed into a curated display together with the recordings thus providing a thought-provoking participant and visitor experience which will encourage reflection, discussion, and shared explorations of the sentimental bonds that connect us to our past. Held in the atmospheric crypt of Holy Trinity Church, the venue enhances the event's theme—highlighting how these objects provide emotional comfort and continuity yet, ultimately, remain as echoes of the lives they once belonged to.

# How will the funding benefit the community or residents of Weymouth?

This funding will enable Artwey CIC to deliver a range of arts projects that foster mental well-being, social cohesion, and cultural awareness. Through accessible visual arts experiences, we will engage residents, support disadvantaged and marginalised groups, and promote integration for immigrants. By attracting visitors from outside Weymouth and Portland, our activities will also contribute to the local economy while enhancing the area's artistic and cultural identity.

# How do you know that the groups you work with, or the local community, want this project to take place?

We have directly engaged with partner organisations to ensure that our initiatives align with their clients' needs. They have confirmed that our work will improve public understanding of their challenges while offering meaningful artistic engagement. Additionally, discussions with members of the public have sparked strong interest in the project themes, demonstrating a demand for these activities.

# How will this funding lead to greater self-sufficiency and lessen the need for future applications?

This is a one-off application to support Artwey CIC's involvement in Town of Culture events. By delivering engaging arts experiences, we will strengthen our reputation and reach and hopefully attracting wider community support and future investment.

10. What fund-raising activities took place in the **last** 12 months and what fund-raising activities are planned for the **next** 12 months, if any? Anticipated income/expenditure for the next 12 months?

We are constantly trying to raise funds. We do this through member subscription, donations and grant applications.

Our annual income from member subscriptions is projected to be about £6000. We fund most of our activities such as our free to the public life drawing classes and our artist exhibitions through this. We have increased our membership by 30% in the last few years but there is a limit to the number of members we can allow because of the amount of work involved in administering the membership and events.

We successfully applied for £1000 from We Are Weymouth for our Peace Trail project.

We applied for £3000 grant funding from Weymouth Council for Open for Art and were granted £1700.

We were unsuccessful in our applications for grants to DCC and The Dorset Towns of Culture Reveal Launchpad grant.

Our expenditure will always be about the same as our income because we must fulfil the requirements of a Community Interest Company by investing our income for the benefit of our members and our community. 11.
